Fédération International des Femmes de Carrières Juridiques - FIFCJ Brazilian Association of Women in Legal Careers - ABMCJ

Theme of the Collective Work: "Artificial Intelligence and Gender: Multiple Looks"

The Fédération International des Femmes de Carrières Juridiques - FIFCJ, by its President Manoela Gonçalves Silva, in partnership with the Brazilian Association of Women in Legal Careers - ABMCJ, invites researchers, and other professionals in law and related areas to submit scientific articles to compose **the collective work entitled "Artificial Intelligence and Gender"**. The selected articles will be presented at **the XXV FIFCJ Congress**, which will take place on May 27 and 28, 2025, in Brasilia.

Thematic lines:

1.Impacts of Artificial Intelligence on Gender Inequalities: This line of research seeks to discuss the broad repercussions of artificial intelligence on gender inequalities. Articles should explore how emerging AI technologies are transforming diverse areas, such as the labor market, political representation, *online violence*, accessibility to essential services, among others. AI can both widen and reduce gender disparities, so it is critical to investigate its implications in areas such as digital platforms, remote work, automation, facial recognition, and the ways in which it affects the participation, inclusion and exclusion of women and LGBTQIA+ people in the public and private space.

Line 1 rationale: AI plays a growing role in various spheres of life, from the workplace to digital communication. However, its applications often carry gender biases, often



replicating or intensifying existing inequalities. This line aims to foster an interdisciplinary discussion that makes it possible to understand how these technological systems affect gender equity, and what can be done to mitigate these negative impacts.

2. Intersection between Artificial Intelligence, Gender and Privacy: In this line, the authorsare invited to explore the challenges imposed by AI in relation to privacy, especially in the context of the General Data Protection Law (LGPD) and other surveillance and data collectionsystems. Articles should focus on the disproportionate implications these technologies can haveon women and LGBTQIA+ people, considering aspects such as digital monitoring, data profiling, and the impact of data protection policies on their lives. In addition, it is important to investigate the ethical and legal challenges, as well as the participation of these populations in the formulation of protection and privacy policies.

Line 2 rationale: As AI becomes a prevalent tool in data collection and digital monitoring, there is concern about how these systems address privacy issues, especially for vulnerable groups. Women and LGBTQIA+ people are particularly exposed to these challenges, facing risks related to surveillance and invasion of privacy that can reinforce discrimination. This line aims to stimulate a discussion about the ethical and legal dilemmas surrounding data protection and the ways to build a more inclusive and protective AI.

Rules for Article Submission:

1.Event Participation: Only articles from individuals registered for the 25th FIFCJ Congress will be accepted. Registration for the event is a mandatory requirement for



article submission and will be verified prior to the evaluation of the works.

- 2. Eligibility: Articles must be unpublished and demonstrate a clear relationship with one of thetwo proposed thematic lines, exploring in a thorough and original way the challenges and implications of artificial intelligence in the context of gender.
- 3. Format:
 - a. Size: 15 to 20 pages (including references), with citations in the Author/Date system.
 - b. File format: Word (.doc or .docx).
 - c. Format: A4 size sheet.
 - d. Font: Times New Roman, size 12, spacing 1.5 (except long quotes, which must be in font 11, with single spacing).
 - a. Indentation: First line of paragraphs with indentation 1.5 cm.
 - b. Margins: Top and left 3 cm; bottom and right 2 cm.
 - c. Title structure: Article title centered in bold capital letters; keep two blanks at the top of the page.
 - d. Indication of authorship: Name(s) of the author(s) in bold, followed by email, 2 (two) blanks below the title of the article (and two blanks above the introduction), aligned to the right, with resume summarized in the footer (maximum of four lines, for each authorin the summary resume).
 - e. General structure: Article title in the source language, Article title in English, abstract with up to 5 separate keywords with period, abstract and keywords. Article titles and subtitles should be numbered and bolded. Do not use capital letters in division and subdivision titles. Above the headings and subheadings there should be a blank space; between the headings/subheadings and paragraphs there will be no blank spaces.Finally, conclusion and indication of bibliographic references in ABNT format.
 - f. Explanatory notes should appear (in the number system) at the foot of the page

where they are mentioned (footnote).

g. Citations: Direct citations of up to three lines will be marked with double quotation marks, and inserted in the body of the text. The citations above three direct lines shouldbe made in a new paragraph, with a 4cm indentation from the margin, without quotationmarks, in size 11, justified alignment, spacing between single lines (Zero pt).

- h. Spacing: Spacing of Opts (before and after) between paragraphs.
- i. Images, frames or graphics that accompany the text must be grayscale, inside the document in the space provided and be sent in separate files, in case there is a formatting problem.
- 4. Languages: Portuguese, English, Spanish or French. All articles must contain title and abstract in English.
- 5. Co-authorship: Articles with up to two authors will be accepted.
- 6.Submission: Articles must be submitted through the congress website, under the WORK section (<u>www.congressofifcj.com.br/trabalho</u>), by 11:59 PM (Brasília time) on March 12, 2025.
- 7. Copyright Declaration: Along with the articles, authors must submit the declaration of authorization for publication and transfer of copyright.

Selection:

The articles will be evaluated by a scientific committee appointed by FIFCJ and ABMCJ, with criteria that include relevance of the theme, originality of ideas and technical rigor. The selected works will be published in digital and printed format. The list of articles approved for presentation will be released by March 22, 2025. The presentations will take place on May 28, 2025, during the afternoon of the XXV FIFCJ Congress.
